RE: *Washington Utilities and Transportation Commission v. Sunrise Acres Water Services, LLC*
Commission Staff's Response to Request for Payment Arrangements
Docket UW-180886

Dear Mr. Johnson:

On March 6, 2019, the Washington Utilities and Transportation Commission (Commission) issued Order 02, which classified Sunrise Acres Water Services, LLC (Company) as a water company. Order 02 also ordered the Company to file with the Commission, by April 8, 2019, either a tariff pursuant to the requirements set out in WAC 480-110-433 or, alternatively, a sale agreement documenting that Tom Harrison no longer owns the Company.

On April 11, 2019, Commission staff (Staff) filed a letter stating that, as of that date, the Company had submitted neither a tariff nor a sale agreement and that the Company was therefore in violation of Order 02.

On July 9, 2019, the Commission issued Order 03, which assessed a \$5,000 penalty in Docket UW-180886 for violating Order 02. While the Company ultimately filed a tariff on June 14, 2019, the Company did not submit the tariff until 67 days after the April 8th deadline established by Order 02. Order 03 states the Company must pay a \$5,000 penalty or file jointly with Staff a mutually agreeable payment plan within 20 days of the effective date of this order. The effective date of the order was July 9, 2019.

On September 6, 2019, Staff and the Company came to a mutual agreement on a proposed payment plan consisting of 25 monthly installments of \$200. The Company is aware that this payment arrangement is in addition to the payment arrangement in Docket UW-180885.

The Company is also aware that if it fails to pay any installment by the due date, the entire remaining balance will become immediately due and payable without further Commission order.
