CERTIFICATE OF PROBABLE CAUSE

Statement of Probable Cause

06-04-99 Officer Mattson 426 took a report of Rape of a Child from R/P Paisami Gay 9-2-67. Paisami is the mother of the twin seven-year-old victims REG 6-13-91 and REG 6-13-91. Paisami advised in the initial report that on 4-3-99 at her residence 1203 A Oyster Bay Ave South that Trick had been there for a get together. Paisami advised that on the date of this report her twins disclosed that Trick had laid on them and humped on them and that one of the twins disclosed that Trick digitally penetrated her.

6-8-99 Cynthia Conrad of the SAU interviewed the twin REG's. One disclosed that Trick had placed his hand inside her vagina and anus. The other twin disclosed that Trick had placed his finger in her vagina and had licked her vagina. This twin also disclosed that Trick had placed her hand on his penis and that he had laid on top of her and felt her all over. This twin also disclosed that she observed Trick touching her sister.

7-1-99 I interviewed Trick after he waived his rights. Trick admitted to being in the bed alone with the twins and having his finger in the vagina of one of the twins. Trick admitted to being aroused while thinking about his girlfriend and he mistook the twin for his girlfriend. Trick provided a taped statement.
