16 container of about 13.26 cubic yards and that they will offer the option of loading,
17 multiple pick ups in one day, and that the equipment will allow access to areas that
18 are difficult to get to.

22 **pick up and drop off of solid waste containers?**

23 A: Yes.

25 **Q: What, in your opinion, sets ADE Dumpsters apart from the solid waste**
