In support of the tariff revisions, the Company is providing the following workpapers:

Please note, in addition to the changes to the natural gas base tariff rates approved by Order No. 05, the Company has updated the rates shown under “Other Charges”, which are provided for informational purposes, in order to show on the tariff sheets all of the rate components that encompass the total billing rates shown on the bill. The “Other Charges” changed as a result of the approval of the Company’s recent Purchased Gas Cost Adjustment filing (Schedules 150 & 155 – Docket No. UG-143328), Demand Side Management filing (Schedules 191 & 192 –

Docket No. UG-141210) and the increase to Schedule 192 (LIRAP) as detailed in Order No. 05 in the above referenced natural gas docket.

In addition, the Company requests to cancel the following tariff sheets:

11 th Revision Sheet 159 – Natural Gas Decoupling Rate Adjustment
2 nd Revision Sheet 159A – Natural Gas Decoupling Rate Adjustment
6 th Revision Sheet 159B – Natural Gas Decoupling Rate Adjustment
Original Sheet 94 – BPA Transmission Revenue - Washington

Schedule 159 represents the currently effective natural gas decoupling mechanism which will be superseded by the new decoupling mechanism (Schedule 199) as referenced in Order No. 05, footnote 25.

Schedule 94 represents the BPA Transmission Revenue credit which was designed to refund the 2013 and 2014 share of incremental firm transmission revenues received from the Bonneville Power Administration over a one year period, from January 1, 2014 through December 31, 2014. The BPA Transmission Revenue credit was approved in Docket No. UE-130536. After all bills inclusive of December 31, 2014 usage have been accounted for, the unamortized balance, whether positive or negative, will be transferred to the Energy Recovery Mechanism deferral balance.
