During the week ending Saturday, April 16, 2011, the spur was used one day for crossings. During the week ending Saturday, April 23, 2011, the spur was used two days for crossings. Thus, the average number of days per week that that the spur track was used during the reporting period is calculated as follows:</p> $\frac{3 \text{ days}}{2 \text{ weeks}} = 1.5 \text{ days per week}$ <p>That is less than the subject limitation.</p>
