- c) average number of Washington jurisdictional gas customers;
- d) average number of total (all jurisdictions) gas customers;
- e) annual Washington jurisdictional KWH sales (retail only);
- f) annual total (all jurisdictions) KWH sales (retail only);
- g) Washington distribution circuit miles;
- h) total Avista (all jurisdictions) distribution circuit miles;
- i) Washington distribution miles of mains; and
- j) total Avista (all jurisdictions) distribution miles of mains.

Please note, the Company was unable to provide historical data for all of the requested years in part (g). The query of our GIS system takes a snapshot in time and this level of detail had not been queried in every year unless there was a corresponding rate case filing. For the years where there was not a corresponding general rate case filing in part (h), the Company used the total approximate distribution circuit miles reported in the Company’s 10k filings.
