On June 14, 2021, the Washington Utilities and Transportation Commission (the "Commission") issued Order 01 in Docket UE-210220, in which the Commission approved the Revised Draft All-Source Request for Proposal submitted by Puget Sound Energy ("PSE") in that docket, subject to the following conditions recommended by Commission Staff and adopted in Order 01:

- (1) PSE must post workshop materials to its Request for Proposal ("RFP") website at least seven calendar days prior to each workshop and that materials for the [Effective Load Carrying Capability (ELCC)] workshop must include an ELCC review and primer;
- (2) PSE must circulate any Commission notices filed to Docket UE-210220 via PSE's website and email list;
- (3) PSE must file a response to comments filed pursuant to the above-referenced notice within six weeks of the notice's deadline; and
- (4) PSE must remove from the final RFP the requirement for a cost adder for a return on power purchase agreements.²
