TO ALL PARTIES:

On June 1, 2017, Pacific Power & Light Company (Pacific Power or Company) submitted to the Washington Utilities and Transportation Commission (Commission) its 2016 Power Cost Adjustment Mechanism (PCAM) filing for approval. On October 2, 2017, both Commission staff and Boise White Paper, L.L.C. submitted letters to the Commission requesting that the matter be set for adjudicative proceeding.

On October 23, 2017, the Commission convened a prehearing conference in this docket and adopted an agreed procedural schedule. On October 26, 2017, the Commission entered Order 01; Prehearing Conference Order; Notice of Hearing, which established the procedural schedule, including an evidentiary hearing set for April 4, 2018.

On November 8, 2017, Pacific Power filed a Motion to Amend the Procedural Schedule (Motion). The motion stated that the established hearing date would prevent certain company witnesses from being present, and requested a revised schedule, which included a proposed hearing date of April 16, 2018. No parties objected to the Motion.

On December 14, 2017, the Commission contacted the parties to inform them that the Commission was unavailable for hearing on the suggested date, and asked the parties to confer and propose an alternate schedule.
