Verizon Northwest Inc. submits for filing Advice No. 3141 containing the attached tariff sheets to become part of the General and Local Exchange Tariff, WN U-17. An original and fifteen (15) copies are being provided pursuant to Paragraph 15 of Order No. 3 in Docket No. UT-040788.

The company submits this Advice filing in compliance with the Commission's Order No. 15 in Docket No. UT-040788 dated April 12, 2005. This submission contains the complete set of tariff sheets filed with the Settlement Agreement on February 23, 2005, with the exception of the tariff sheet filed on April 15, 2005 regarding the new late payment charge and with the exception of the revisions noted below. Per ALJ Wallis' request, all parties were given an opportunity to review the revisions that were made to the tariff and price list sheets after the settlement agreement was filed on February 23, 2005. No party objected to the revisions, which for the most part are not substantive in nature.


