omits revenues from Special Contracts. In addition, classification of costs between line 9, "447 Sales for Resale," and credits to line 8, "555 Purchased & Interchange," require revision consistent with SAP accounting reports. Finally, some actual costs during February 2001 were incorrectly classified as line 8, "555 Purchased & Interchange," when they should have been included in line 17, "557 Comp. Bid, Consulting & Other Exp."

3. These changes affect the Direct Testimony of K.R. Karzmar, Exhibit KRK-4, Exhibit DEG-3, and Proposed Order Exhibit A, which require correction consistent with the corrections to WAG-4.

4. Therefore, please replace the documents PSE initially filed in this proceeding with the attached substitute pages 5 and 6 of the Direct Testimony of K.R. Karzmar, corrected Exhibit WAG-4, corrected Exhibit KRK-4, corrected Exhibit DEG-3, and corrected Exhibit A to the Proposed Order.<sup>1</sup> PSE apologizes for any confusion this may have caused.
