### Short intro to the UTC and RCW 80.28.430

### The Utilities and Transportation Commission regulates the investor-owned utilities in Washington:

- Avista
- Puget Sound Energy
- Pacific Power
- NW Natural
- Cascade Natural Gas

#### RCW 80.28.430:

- Statutory authority for energy utilities to provide financial assistance to certain organizations participating in UTC regulatory processes.
- The Commission must approve/reject/modify agreements as well as set certain standards.
- Requires prioritization of vulnerable populations and highly impacted communities.




### RCW 80.28.430 Implementation Timeline

#### November 2021 policy statement:

- Funding caps
  - At least 1/3 reserved for prioritized organizations
- First year of funding is a learning opportunity
- Continued outreach and engagement with prioritized organizations
- Administrative process outline

#### February 2022 interim agreement:

- Largely modeled from Oregon agreement with provisions to meet Commission policy statement
- Negotiated between utilities and interested parties
- More detailed administrative processes and timelines for those seeking funding to meet
- Commission approved the agreement with modifications

# Concurrent Phases of Implementation

Phases 1 and 2 are complete:

- Develop and issue interim funding policy statement guiding initial agreements and program – COMPLETED Nov. 19, 2021
- 2. Commission review and approval of an interim joint utility-stakeholder participatory funding agreement COMPLETED Feb. 24, 2022

3. Administration of existing funding agreements

6. Monitoring and evaluation

4. Technical assistance to new organizations

5. Outreach to prioritized organizations



### Phase 3: Administration of Agreements

- Administration takes place during the proceeding for which a participant is requesting funding, as well as the generic policy statement docket (U-210595), and includes review of requests for funding, budgets, and requests for payments.
  - Lead sections: Administrative Law Division/Policy/Commissioners
  - Timing: On-going
  - Opportunities:
    - Customer notice and disconnection fees rulemaking: <u>U-210800 Customer Notice & Fees</u> <u>Rulemaking</u>
    - Potential use for funding in adjudication of CEIPs
    - Performance-based rate-making docket
    - Rate cases



# Phase 4: Technical Assistance

- Includes procedural and issues-based technical assistance:
  - onboarding new organizations
  - providing Commission 101 information, definitions, case summaries, and issue explainers
  - explaining procedural dates and requirements
- Comingles with administration of existing agreements as new parties have questions about UTC work and comingles with outreach work.





# Participatory funding for technical assistance

"...The Commission also makes clear that training and education that provides technical assistance to organizations representing highly impacted communities and vulnerable populations about the subjects of utility regulation and Commission proceedings and case law are considered eligible uses for funding."

Policy statement, paragraph 52



# UTC plans for 2022 technical assistance

- Developing fact sheets and website information with funding program information, including amounts of funding still unallocated for the year

- Planning a workshop to introduce the commission and its work as well as the participatory funding program for July.

# Phase 5: Outreach to Prioritized Organizations

- Includes the additional work discussed by the commission in its policy statement such as direct outreach to prioritized organizations for policy and procedural feedback on funding program design and to explain existing opportunity
- Comingles with technical assistance as organizations with whom the UTC is engaging have fundamental questions about UTC work

"The Commission acknowledges there is additional work to be done engaging organizations that represent highly impacted communities and vulnerable populations to better understand how to design a participatory funding program that meets and prioritizes their needs as required by the statute."

developing awareness of participation

opportunities for vulnerable populations and

highly impacted communities."


# UTC plans for 2022-2023 outreach

• Issuing an RFP this summer to hire a consultant to conduct engagement research. Expecting a report outlining prioritized organizations who would benefit from funding opportunities, barriers to engagement, and recommendations for engagement opportunities. UTC will use report recommendations to strategize additional work.



# Phase 6: Monitoring and Evaluation

 Monitoring and evaluation of interim policy statement, interim funding agreement, and implementation of funding program to inform additional policy guidance after the first year of implementation



"... The Commission may provide additional guidance after administering these initial funding agreements and gaining more experience and insight into the needs of organizations representing prioritized communities."

Policy statement, paragraph 4

"...We will measure the program's success, in part, by surveying new participants to ensure they have a clear understanding of how our processes work, by the feedback we receive from those participants on whether they have had an effective opportunity to participate in our regulatory proceedings, and by the feedback we receive from prioritized communities about whether they feel heard and represented in our proceedings."

#### Outreach

#### Monitoring and Evaluation

Training and administrative assistance for organizations that represent vulnerable populations and highly impacted communities to better equip these organizations to navigate energy utility regulation and UTC proceedings.

Engagement with prioritized organizations to both inform diverse, non-utility groups about the availability of funding and to gather their input regarding additional program design to create an equitable mechanism for participatory funding.

Gathering learning across program areas, including administration and outreach, to inform potential future policy guidance that guides the participatory funding program.

Example: Orientation workshops providing information about the UTC's role in the Clean Energy Transformation Act, explaining how organizations can participate.

Example: Focus groups to gather input about barriers community organizations face accessing funding and resources to participate in UTC proceedings.

Example: Survey to program participants about accessibility of the program.





# RCW 19.405.020 defines vulnerable populations and highly impacted communities

### "Vulnerable populations"

Communities that experience a disproportionate cumulative risk from environmental burdens due to: Adverse socioeconomic factors, including unemployment, high housing and transportation costs relative to income, access to food and health care, and linguistic isolation; and sensitivity factors, such as low birth weight and higher rates of hospitalization.

### "Highly impacted community"

A community designated by the department of health based on the cumulative impact analysis required by RCW 19.405.140 or a community located in census tracts that are fully or partially on "Indian country," as defined in 18 U.S.C. Sec. 1151.
