In accordance with the terms adopted in Order 05 in docket UG-200568, this filing will decrease the Company's revenues by \$390,563 or 0.15 percent. In addition, Cascade was unable to directly tie two restating adjustments (R-1 and R-6) as explained within Order 05 with the results reflected within the Order 05 Attachment; regardless, Cascade adjusted its results to reflect the Commission's overall revenue decrease of \$390,563. Furthermore, Cascade will be seeking for clarification or reconsideration on one discreet adjustment.

The tariff changes proposed herein are consistent with the tariff revisions proposed in the Direct Testimony of Pamela J. Archer included in the Company's initial general rate case filing as Exhibit PJA-1T. The exception to these changes is schedule No. 597, which is revised in order to zero out rates in effect November 1, 2020, per WUTC Pipeline Replacement Policy Statement.
