The recent mass resignations of the HYDRO ONE Board of Directors, the firing of its CEO and my continuing concerns about the lack of transparency regarding the merger make it imperative now that I insist on coordination as to the matter.

My ongoing concern arises from my duties to protect the economic stability of the County, a stability that requires assurance of dependable and reliable energy supply for home and business. In turn, that reliability is dependent upon a sound government structure of the County, a soundness that I work regularly to maintain. My duties include cash custody, banking and financial services, investments, revenue collection and debt payment services for over 80 local districts within the County, including 19 school districts, 11 fire districts, 13 cities and towns and villages and 5 legislative districts.
