In accordance with WAC 480-07-640, Company A requests approval of the fully negotiated amendment to an interconnection agreement, as described below:

Amendment No. 10 modifies the Performance Assurance Plan and Performance Indicator Definitions, included as Exhibit B to this amendment, said modifications and amendments described in this amendment, attached hereto and incorporated herein by this reference.

This amendment amends the interconnection agreement first approved by the Commission on August 14, 2002 in WUTC Docket No. UT-023037 (current docket number) between Qwest Corporation and Electric Lightwave, Inc.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest.
