DEQ has reviewed the most recent DNAPL Monitoring Semiannual Report for the period between January 1 through June 30, 2023. The DNAPL Semiannual Report includes a request to modify the monitoring frequency at certain wells. DEQ approves the recommended monitoring frequency adjustments discussed in Section 6 of the report.

DEQ makes the following observations about the data presented in the monitoring report:

- DNAPL entry rates at PW-14U appear to have spiked during the monitoring period compared to previous DNAPL entry rates.
- DNAPL entry rates for PW-6U appear to have spiked at the end of the monitoirng period compared to previous DNAPL entry rates.
