1 On June 28, 2002, J & M Disposal, Inc., filed an application (No. GA-079086) for a certificate of public convenience and necessity to operate motor vehicles in furnishing solid waste collection service consisting of construction and demolition debris in King and Pierce Counties in the state of Washington. Notice of the Application was published in the Commission’s weekly Docket of July 8, 2002.

2 The issues in this proceeding include whether the issuance of a certificate to J & M Disposal, Inc., for the service it proposes is necessary and is otherwise consistent with the public interest, and whether other carriers are authorized to serve in the territory requested. The Commission has jurisdiction over this matter under Title 81 RCW, which authorizes it to regulate persons seeking to furnish solid waste collection services under chapters 81.77 RCW and 480-70 WAC.

3 The statutes involved include those within chapter 81.04 RCW, chapter 81.28 RCW and chapter 81.77 RCW, including but not limited to RCW 81.77.040. Rules involved include those within chapters 480-70 WAC and 480-09 WAC.

4 The Commission sets a prehearing conference to discuss preliminary matters, the hearing process, and to formulate the issues.

5 **NOTICE IS GIVEN That a prehearing conference in this matter will be held on Wednesday, November 13, 2002, beginning at 10:00 a.m., in Room 108, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**

6 NOTICE IS ALSO GIVEN THAT ANY PARTY WHO FAILS TO ATTEND OR PARTICIPATE IN THE HEARING SET HEREIN, OR OTHER STAGE OF THIS PROCEEDING, MAY BE HELD IN DEFAULT IN ACCORDANCE WITH THE TERMS OF RCW 34.05.440. THE PARTIES ARE FURTHER ADVISED THAT THE SANCTION PROVISIONS OF WAC 480-09-700(4) ARE SPECIFICALLY INVOKED.
