Certificate of Public Convenience and Necessity No. C-1054 stands in the name of Jeffrey Lynn Porter, d/b/a Pennco Transportation, and authorizes passenger service as therein set forth.

On January 8, 2003, a joint application, D-79127, was filed for authority to transfer all rights under said Certificate No. C-1054 to Pennco Transportation, Inc.

It appears that Pennco Transportation, Inc., is able and willing to furnish all services necessary under Certificate No. C-1054 , and that the transfer of all rights as requested will not be detrimental to the interests of the public.

ORDER

WHEREFORE, IT IS ORDERED That the application be, and the same is, hereby granted, conditioned upon compliance by all parties concerned with the law and rules governing auto transportation companies, and subject to any legal claims, liens or equities.

AND IT IS FURTHER ORDERED That Certificate of Public Convenience and Necessity No. C-1054 be reissued to Pennco Transportation, Inc., per attached Appendix A.

All parties interested should take notice that the Commission in granting authority for the transfer of rights under a certificate does not necessarily approve the amount involved in the transaction, nor does it bind itself to recognize such amount in placing a value for rate-making purposes on the property of the certificate holder.

APPENDIX A

PASSENGER SERVICE: Door-to-door, by reservation only:

BETWEEN: Port Angeles and points in Clallam and Jefferson Counties.

BETWEEN: Clallam and Jefferson Counties, and Seattle and Tacoma hospitals, Amtrak stations, Greyhound stations, and the Seattle-Tacoma International Airport with closed door service between Clallam and Jefferson Counties, and the indicated points in King and Pierce Counties.

BETWEEN: Clallam and Jefferson Counties and Port Townsend, Port Ludlow, and Silverdale, for passengers whose point of origin or point of destination is in Clallam or Jefferson County.

Conditions: Pennco may not provide service to passengers from any point served by Heckman Motors, Inc., d/b/a Olympic Bus Lines, under Certificate No. C-992 without advance reservations made at least one hour in advance of the pick-up times at each such point indicated by Heckman Motors, Inc., d/b/a Olympic Bus Lines, schedule as published from time-to-time in accordance with WAC 480-30-060.

The holder of this certificate may operate a five foot by eight foot trailer when such a trailer is used to carry baggage or express and is towed by a vehicle in which passengers are being transported.
