On January 21, 2004, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible corrections and changes to the rules in Chapter 480-120 WAC, Telephone Companies, and Chapter 480-80 WAC, Utilities General—Tariffs, Price Lists, and Contracts, relating to telecommunications. The CR-101, as filed with the Code Reviser, is available for inspection on the Commission's web site at www.wutc.wa.gov/040015. The Commission recently completed a comprehensive review of its rules in Chapter 480-80 that took effect in June 2002, and its rules in Chapter 480-120 that took effect in July 2003. In the process of implementing these rules, stakeholders and agency staff have identified a variety of issues with the rules.

- Definition of Class A and Class B companies (WAC 480-120-021, WAC 480-120-302)
- Prohibition on using ADADs to dial unlisted numbers (WAC 480-120-253)
- Clarify obligation of LECs to update E-911 information (WAC 480-120-450)
- Cross-references to "deceptive practices" (WAC 480-120-173, 480-120-122)
- Application of terminating access rule to CLECs (WAC 480-120-540)
- Requirement to offer WTAP service (WAC 480-122-020)
- Response to informal complaints (WAC 480-120-166)
- Emergency contact information (WAC 480-120-414)
- Definition of a tariff change not subject to statutory notice (WAC 480-80-123)
- Requirement to include contact information in price lists (WAC 480-80-102)
