¹ In 2003, the legislature enacted statutory changes to Chapter 81.53 RCW concerning the Grade Crossing Protective Fund. The Commission issued its Interpretive and Policy Statement on November 26, 2003, to implement the legislature's statutory changes for the biennium ending June 30, 2005.
