3. The temporary 1.12% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of January and February 2006, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of March 2006 and April 2006.

Customers who are billed bi-monthly for services -current month and one month ahead:

The surcharge will appear on the April 2006, billing and applies to all services provided in the months of April 2006, and May 2006.
