On May 12, 2006, Puget Sound Energy, Inc. ("PSE" or "the Company") filed revised Schedule 95 tariff sheets reflecting a new power cost baseline rate with an effective date of July 1, 2006, in compliance with the Commission's Order No. 04 in Docket No. UE-050870 (the "2005 PCA Order").

The parties to Docket UE-050870 reviewed the filing and on June 22, 2006, the Company submitted substitute tariff sheets which reflected all of the corrections identified by the other parties to date that the Company believed were required to make PSE's May 12, 2006, filing consistent with the 2005 PCA Order. However, additional changes were identified by the parties which necessitate a further submittal of substitute tariff sheets.

Please find enclosed for filing the following proposed revisions to the WN U-60, Tariff G for electric service of PSE:


