- 1 University Place Refuse Service, Inc., holds Certificate of Public Convenience and Necessity No. G-64. Certificate No. G-64 was issued under the provisions of RCW 81.77 and authorizes solid waste collection service in portions of Pierce County.
  
- 2 The commission in its GIS (Geographical Information System) mapping project found that Certificate No. G-64 included outdated road names and unclear boundary descriptions that should be corrected to properly reflect the authorized territory.
  
- 3 In view of this fact, on August 24, 2006, University Place Refuse Service, Inc., filed a request to revise and reissue Certificate No. G-64 to reflect the corrected road names and boundary descriptions suggested by staff in the GIS mapping project.

ORDER

4 IT IS ORDERED That Certificate of Public Convenience and Necessity No. G-64, standing in the name of University Place Refuse Service, Inc., be revised and reissued as described in the attached Appendix A.

## APPENDIX A

PID102 SOLID WASTE COLLECTION SERVICE in Fircrest, University Place and from within an area in Pierce County described as follows: Beginning at the northern-most tip of Day Island and including all of Day Island; thence east following S. 19th Street to its intersection with S. Orchard Street; thence south following S. Orchard Street to its intersection with 40th Street W. (Emerson Street); thence west following 40th Street W. (Emerson Street) to its intersection with Leach Creek; thence southerly following Leach Creek to its intersection with 48th Street W. extended; thence west following 48th Street W. extended to its intersection with Alameda Avenue W.; thence south on Alameda Avenue W. to its intersection with Cirque Drive W.; thence on a line due south to Leach Creek; thence southerly following Leach Creek to the point where it empties into Chambers Creek; thence westerly following Chambers Creek to the point where it empties into Puget Sound; thence northerly following the shoreline of Puget Sound to the northern-most tip of Day Island, the point of beginning.
