**NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS ON  
CR-101 AND DISCUSSION DRAFT  
(By Tuesday, November 27, 2007)**

RE: Rulemaking to Consider Amending WAC 480-93, Relating to Gas Companies -  
Safety, Docket PG-070975

TO INTERESTED PERSONS:

On July 26, 2007, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) at WSR # 07-16-060 to consider possible corrections and clarifications to selected sections of WAC 480-93 to reflect changes in RCW Title 81 resulting from the passage of Substitute Senate Bill 5225 during the 2007 legislative session. This notice supplements the original CR-101 filed at WSR 07-16-060.

On October 24, 2007, the Commission filed a supplemental CR-101 to that noticed at WSR # 07-16-060 to consider moving back by two months the fee-setting and fee-payment schedules in WAC 480-93-240, and to provide greater detail for what must be included in a petition contesting the fee. The supplemental CR-101, filed with the Code Reviser at WSR # 07-21-147, is available for inspection on the Commission's web site at [www.utc.wa.gov/070975](http://www.utc.wa.gov/070975). The Commission has completed a discussion draft of rules in WAC 480-93 that incorporates the statutory changes and modifications to the fee-setting and fee-payment schedules mentioned above. The discussion draft is available for inspection on the Commission's web site noted above.
