I provided educational and technical assistance to Blue River Travel Corp LLC, co-owners Hang Jun Duan and Sheng O at their Kirkland, WA terminal. The safety manual "your guide" was handed to the company and the regulations were reviewed. I conducted a level 7 jurisdictional vehicle inspection of the company's minibus. No defects were noted and the inspection has been up loaded to the federal MCMIS database. The safety regulations were reviewed regarding: alcohol and substance abuse testing requirements, maintaining complete driver qualification files, especially medical examination certificates, hours of service regulations, in particular the 100 air mile driver vs. the over 100 mile radius driver (the company has plans to transport charter passengers in the Seattle metro area and to Vancouver, B.C. Canada. This applicant is in the new entrant program and has been contacted by a new entrant auditor to schedule the safety audit under their interstate authority MC 924153. The vehicle inspection, repair, and maintenance regulations were reviewed including the need for the company to keep current their periodic (annual) vehicle inspection and push out window inspections each 90 days.
