
In the Matter of the 2018 Public Works Fee Schedule

#### Overweight:

- Fee schedule as identified in RCW 46.44.0941
- Fee based on County Road lane miles only
- Any costs incurred by the County for evaluation of bridges and culverts associated with the requested permit shall be reimbursed to the County prior to issuance of the overweight permit. Alternate reimbursement options such as deposit or bond may be authorized by the Public Works Director on a case by case basis.

#### Construction/Utility Inspection

Activity does not disturb roadway or appurtenances	No Charge
Activity involves excavation in roadway or appurtenances:	
Per each excavation:	\$ 150
Per continuous excavation or plowing (\$150 minimum):	\$ 1,250 per Mile

#### Other
