DECLARATION OF BRIAN BRAUN

Brian Braun, under penalty of perjury under the laws of the State of Washington, declares as follows:

- 1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
- 2. On April 17, 2018, on www.classifiedads.com, I found an advertisement for "Always Movin' Moving Company" under the category "Seattle: Everett Moving & Storage." The advertisement was created on April 4, 2018, and offered "2 movers & truck \$115 per hr." The advertisement displayed the telephone number "425-979-1119," email address alwaysmovin4u@gmail.com, and the website URL "alwaysmovin.com."
- 3. On April 17, 2018, I visited the website "www.alwaysmovin.com." ² I observed the telephone number "425-979-1119," an advertisement stating "Welcome to Always Movin'. Quality Licensed & Bonded Movers Based in Mill Creek near 405 and I-5." I also observed the company address "17003 9th Ave. SE Mill Creek, WA 98012," and an email address "joel@alwaysmovin.com."
- 4. On April 17, 2018, I searched Facebook for "Always Movin' Moving Company" and found a company profile.³ On the company profile I found an advertisement for a "Cargo & Freight Company in Mill Creek, Washington," a telephone number of "(425) 979-

1119," a web address of "alwaysmovin.com," and an email address of "alwaysmovin4u@gmail.com."

- 5. On April 17, 2018, I searched Yelp for "Always Movin." I found a claimed Yelp profile that had a web address of "alwaysmovin.com," a telephone number of "(425) 979-1119," and a section "From the business History" that stated, "Joel Cisneros, the owner is an experienced mover and brings these skills from his former career to AlwaysMovin.com."
- 6. On April 17, 2018, I searched Commission records and verified that Always Movin' Moving Company or Joel Cisneros were not permitted household goods carriers.
- 7. On April 18, 2018, I sent a compliance letter to Joel Cisneros, Always Movin' Moving Company notifying Mr. Cisneros to cease and desist operations as a household goods carrier in Washington State until he obtains the required household goods carrier permit from the Commission.⁵
- 8. On May 23, 2018, posing as a consumer, I used the alwaysmovin.com website portal to book an online quote for a move between two points in Washington. I then received an email⁶ from Joel Cisneros at joel@alwaysmovin.com asking for clarification on my move, and received a quote of "an hourly rate at \$100.00 per hour." This included two movers and a truck.
