

IMPORTANT NOTICE FOR PUGET SOUND ENERGY CUSTOMERS ABOUT PROPOSED CHANGES IN RATES

Puget Sound Energy, on Oct. 31, 2018, and on Nov. 27, 2018, filed requests with the state Utilities and Transportation Commission (UTC) to adjust electric and natural gas rates. The requested changes, proposed to be effective on Jan. 1, 2019, are included in the Other Charges & Credits amount(s) listed on PSE bills:

Federal Wind Power Credit: An annual true-up of the pass-through of federal income tax benefits derived from PSE's investments in the utility-owned and operated Wild Horse Expansion and Lower Snake River wind facilities. The filing requests to decrease the credit, which will increase electric rates for most customers.

Renewable Energy Credit: Due to an increase in the level of Renewable Energy Credit sales, PSE requests to increase the credit which will result in a decrease in electric rates.

Merger Credit: A 10 year period of rate credits was established in February 2009. The time period has been completed and PSE requests to terminate the credit, causing an increase in electric and natural gas rates for customers.

NATURAL GAS RATES: For the typical residential customer with natural gas service using 64 therms per month, the effect of the rate change will increase a typical PSE monthly bill by 23 cents, or 0.39 percent.

ELECTRIC RATES: The combined effect of all three rate changes for the typical residential customer using 900 kWh of electricity per month will increase a typical PSE monthly bill by 42 cents, or 0.47 percent.

The overall average changes for electric and natural gas customers are as follows:
