Washington Utilities and Transportation Commission v. 3Z Movers LLC Commission Staff's Response to Request for Payment Arrangements

Docket TV-190037

Dear Mr. Johnson:

On February 5, 2019, the Washington Utilities and Transportation Commission (commission) assessed a \$1,900 penalty in Docket TV-190037 against 3Z Movers LLC (3Z Movers or company) for violations of Washington Administrative Code (WAC) 480-15-180, Carrier Operations that Require a Household Goods Permit; WAC 480-15-560, Equipment Safety Requirements, which adopts Title 49 CFR Part 396 – Inspection, Repair, and Maintenance; and WAC-480-15-570, Driver Safety Requirements, which adopts Title 49 CFR Part 390 – Safety Regulations, and Title 49 CFR Part 395 – Hours of Service of Drivers.

On March 4, 2019, 3Z Movers contacted commission staff to request a payment plan for the \$1,900 penalty. On March 14, 2019, Staff and the company came to a mutual agreement on a proposed payment plan consisting of 19 monthly payments of \$100 each month, as follows:
