NOTICE OF BRIEF ADJUDICATION

SETTING TIME FOR ORAL
STATEMENTS

**(Set for April 7, 2020,
at 9:30 a.m.)**

- 1 On February 7, 2020, the Washington Utilities and Transportation Commission (Commission) issued a Notice of Intent to Cancel Certificate; Notice of Opportunity for Hearing (Notice) in this matter. The Notice informed Blessed Limousine, Inc., (Blessed Limo or Company) that the Commission intended to cancel the Company's certificate for continued failure to comply with Commission rules pertaining to charter and excursion carriers.¹ The Notice gave Blessed Limo the opportunity to request a hearing to contest the factual allegations set out in the Notice.
- 2 On February 26, 2020, Blessed Limo filed with the Commission a request for hearing.
- 3 Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the violations occurred.
- 4 **THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m. on Tuesday, April 7, 2020, in the Commission's Richard Hemstad Hearing Room, 621 Woodland Square Loop SE, Lacey, Washington.**
- 5 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.

6 Written notice of any other stage in the proceeding or other formal proceedings that the
Commission may deem appropriate will be given during the course of this case. The
Commission will provide at its offices in Lacey, Washington, copies of documents in the
current record for use by the parties or others who may want to review them.

7 Parties wishing to submit any other documents for consideration at the brief adjudicative
proceeding must file with the Commission all such documents, as well as a list
enumerating such documents, no later than **5 p.m. on Tuesday, March 31, 2020**, and
bring an original and one (1) copy to the hearing. Filing shall be in accordance with
WAC 480-07-140.

8 **THE COMMISSION GIVES NOTICE that any party who fails to attend or
participate in the brief adjudicative proceeding set by this Notice, or any other stage
of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-
450.**
