Puget Sound Energy (“PSE”) hereby submits in connection with Docket UE-200142 the following tariff sheets to replace the tariff sheets that accompanied PSE’s February 28, 2020 filing which was submitted under PSE’s Advice No. 2020-05. This filing includes the following portion of the Company’s WN U-60 tariff for electric service.

The purpose of this filing is to amend the revenue requirement which originally included an additional 2020 conservation budget allocation of \$7.0 million, estimated to comply with the requirements of the Clean Energy Transformation Act (“CETA”) and lower originally filed rates. The additional budget amount was revised downward following the March 18, 2020 Conservation Resource Advisory Group (“CRAG”) consultation. Work papers reflecting this change accompany the filing.

Additionally, PSE hereby submits in connection with Docket UE-200142 a cover letter to replace the cover letter accompanying PSE’s February 28, 2020, filing which was previously submitted under PSE’s Advice No. 2020-05. This substitution is being made to correct a typographical error. PSE is re-submitting its cover letter to correct the revision numbers for the tariff sheets included with the filing.
