Your last message did not address the issue, and given what you have indicated during our phone conversations, it is apparent that you will be unable to complete the requirements of WAC 480-30-186(2)(a) due to the company already being shut down for all intents and purposes. After discussion, Staff has arrived at the conclusion that the best course of action is for you to petition for an exemption to WAC 480-30-186(2)(a). Staff will support this petition and unless the Commission ruled otherwise, you would not need to demonstrate that you met the requirements of WAC 480-30-186(2)(a). To move forward with this, I need you to reply with a statement acknowledging that you are petitioning for an exemption to WAC 480-30-186(2)(a).
