This billing true-up will be collected from customers for the period of April 1, 2020 through March 31, 2021.

Above rates include \$4.55 per yard, per pick-up for recycling service.

An additional charge of \$.75 per unit will be assessed to all Multi Family complexes who elect not to recycle or who do not provide adequate recycling service to the complex. Adequate recycling service is defined as 16-gallons of available recycling volume per multi-family unit, per week.
