Tariff No. 6, 10th revision, Page 35 Item 230 disposal fees for disposal cost at Ephrata Landfill is \$27.80 per ton.

Proposed changes are:

Consolidated Disposal Service, Inc. proposes revising Tariff No. 6, 11th Revision, Page 35, Item 230 for putrescible waste disposal service to become effective on less-than-statutory notice on March 1, 2021. The per ton rate notice from Ephrata Landfill shows the rate has increased from \$27.80 per ton to \$47.62 per ton. Consolidated Disposal Service, Inc. serves approximately 18,500 residential and 1,750 commercial customers in Grant and Adams County. Copies of the notices from Grant, Adams and Lincoln Counties are attached to this LSN, along with a notice from the Greater Wenatchee Regional Landfill.

The proposed effective date of the disposal fee increase is March 1, 2021. Customers will be notified of the increase on the next billing cycle.
