The purpose of this filing is to replace Sheets 95-M and 137-G from PSE's electric tariff with Sheets 95-M.1 and 137-H, to allow the Company to submit its annual filings of its electric Schedules 95A and 137. The replacement of these tariff sheets are being made following discussions with Commission Staff.

Additionally, this substitute filing extends the effective date of PSE's proposed tariff sheets to January 1, 2022, consistent with discussions with Commission Staff. Accordingly, the tariff sheets described herein reflect the original issue date of October 1, 2021 and a revised effective date of January 1, 2022.

Notice and posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being completed in accordance with WAC 480-100-193(1). Notice to the public under the provisions of WAC 480-100-194 will be provided within 30 days of the January 1, 2022, effective date.
