**SUPPLEMENT TO PETITION**

Global Connection Inc. of America dba StandUP Wireless (“StandUP Wireless” or the “Company”), by its undersigned counsel, and pursuant to Section 214(e)(2) of the Communications Act of 1934, as amended (the “Act”)<sup>1</sup>, Sections 54.101 through 54.207 of the Rules of the Federal Communications Commission (“FCC”),<sup>2</sup> and Section 480-123-030 of the Washington Administrative Code (“WAC”), hereby supplements its pending Petition for Designation as an Eligible Telecommunications Carrier (“ETC”) in the State of Washington which was filed on July 6, 2022 (“Petition”).

By this supplement, StandUP Wireless files a revised Exhibit 2 to reflect the Company’s Tribal Lifeline rate plan offer, showing that residents of federally recognized tribal lands will receive unlimited talk, text and 6.5 gigabytes (GB) of data at a net cost of \$0.00 after application of Lifeline support, or unlimited talk, text and up to 60 GB data at a net cost of \$0.00 after application of combined Lifeline and ACP support. Also attached is a revised Exhibit 5 to identify
