Proposed changes are to add a Special Fuel Surcharge Supplement No. 1 in the amount of 1.77%.

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: December 1, 2022.

3. The temporary 1.77% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of April 2022, May 2022 and June 2022, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of December 2022, January 2023 and February 2023

Customers who are billed bi-monthly for services – current month and one month in advance:
