<b>* Present provisions are:</b> A 45 day notice to customers
<b>* Proposed changes are:</b>  As stated in WAC 480-70-271 (2)(a), we are requesting to be allowed to notify customers on their first bill.
<b>* Explain why the company is proposing this tariff revision:</b>  Recent potential interpretations of RCW 81.28.050 make it unclear whether the long-standing practice of following WAC 480-70-271 (2)(a) can be done without a L.S.N. form when submitting a disposal-only rate filing.
<b>* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):</b>  We have not requested the revision of rates to take effect in less than 45 days, we are asking that the customer notice can be completed as outlined in WAC 480-70-271 (2)(a)
