Dear Domestic Customers,

Summit View Water Works LLC (Summit View) has filed with the Washington Utilities and Transportation Commission (UTC) a request to adjust the domestic water rates which may result in a change in the rates on your invoice. If the UTC approves this request, new rates will become effective September 1, 2024.

Summit View has not had a rate increase since 2020 but has continued to experience increases in operating expenses over that interval. We have also requested that the UTC allow this rate adjustment to be phased in over a period of two years. Set forth below are the proposed adjustments to domestic customer rates over that time period:
