History summation:

PSE representative Bob Douglas made contact with crew on this job site on 8/29/24, the crew was on site excavating before ticket work to begin date of 08/31/2024. Bob Douglas made them aware of this and emailed Chris Miller about the situation. On 9/12/24 Bob Douglas went back out and found damaged ¾ STW service buried without being reported or repaired. Miller Bros did not call and report the damage. When Bob requested the Miller and MN meet him on site, only Drew Garris from MN Homes did so. Miller Bros did not attend. The contractor had also damaged a phone line in the same area and Bob reached out to that utility to inform of them of the damage. Reviewing all this information they were out of compliance on [RCW 19.122.030(2)], RCW 19.122.040, RCW 19.122.053.




