On May 1, 2009, Puget Sound Energy, Inc. ("PSE" or "Company") filed Revision Seven to the special contract agreement between a predecessor company, Washington Natural Gas Company, and the Boeing Company ("Revision Seven"). The special contract agreement (the "Contract") was approved by the Commission in Docket No. UG-950392. WAC 480-80-143(3) provides that essential terms and conditions of all special contracts are part of the Company's filed tariffs and as such are subject to enforcement, supervision, regulation, control and public inspection as tariffs.

Following discussions with Commission Staff the Company has agreed to provide a revised Revision Seven with an effective date of June 12, 2009. Since the Contract is subject to regulation as a tariff, the Company respectfully requests that the provisions of WAC 480-80-111 be applied to the attached revised Revision Seven to the Contract and it be accepted as a substitute to the Revision Seven filed on May 1, 2009. The only change to the revised Revision Seven is to change the effective date to June 12, 2009 from the original effective date of June 1, 2009. The revised Revision Seven does not make any change to the terms and conditions contained in the original Revision Seven therefore substitution should be allowed.

REVISION SEVEN

This REVISION SEVEN to TRANSPORTATION SERVICE AGREEMENT dated as of April 15, 2009, is entered into by and between the Boeing Company (the "Customer") and Puget Sound Energy, Inc. (the "Company") to revise the Transportation Service Agreement dated as of February 27, 1995, between the Customer and the Company, as revised by Revision One to the Transportation Service Agreement dated as of September 1, 1995, Revision Two to the Transportation Service Agreement dated as of April 1, 2000, Revision Three to the Transportation Service Agreement dated as of May 28, 2003, Revision Four to the Transportation Service Agreement dated as of October 6, 2003, Revision Five to the Transportation Service Agreement dated as of August 1, 2006, and Revision Six to the Transportation Service Agreement dated as of December 22, 2008, all such revisions are between the Customer and the Company.

Effective June 12, 2009:

Section 1. Definitions.

Added Definition:

y. "WNG's tariffed rate schedule for transportation service", "WNG's tariffed rate schedule" or "tariffed transportation service" shall mean or refer to Schedule 87T included in the Company's WN U-2 tariff for gas service.

Formerly:

The Company only had one tariffed schedule for transportation service. As of November 1, 2008 the Company had five such schedules making this added definition necessary.

Section 4. Agreement Term.

Changed to:

40 years commencing on the Effective Date.

Formerly:

20 years commencing on the Effective Date

In all other respects, the aforesaid service agreement shall remain in full force and effect, and this revision shall become a part of and attached to said service agreement.
