Dear Mr. James Naumann:

This letter is to inform you of U S WEST Communications (USWC) plan to file with the State Commissions an amended rate page to your recently approved wireless interconnection agreement. The revision consist of lowering the current nonrecurring charge for trunk routing changes from that of charging on a per trunk basis to charging on a per trunk group basis. This nonrecurring charge applies only when changing from Direct Final to Alternate Final or Alternate Final to Direct Final. The new charge will be effective with the date of your new agreement, pending approval of the individual State Commissions.




