NOTICE OF OPPORTUNITY TO SUBMIT NOMINATIONS AND FILE WRITTEN COMMENTS (By 5 p.m., November 7, 2019)

Re: In the matter of Carbon and Electricity Markets Stakeholder Work Group, UTC Docket UE-190760

TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission or UTC) and the Washington Department of Commerce (Commerce) seek nominations to serve as members of the Carbon and Electricity Markets Stakeholder Work Group (MWG), and for proposals for educational topics and presenters for the first MWG meeting.¹

At the October 24 meeting to discuss MWG formation, the UTC and Commerce indicated that the agencies would seek nominations of members by November 7, 2019. In the event that there are conflicting nominations for statutorily named groups, or to ensure a breadth of composition and membership of the MWG, the UTC and Commerce will determine the

membership of the MWG. The agencies will announce the membership of the MWG by November 15, and work to schedule the first meeting of the MWG soon thereafter.

To assist the UTC, Commerce and MWG members in developing educational topics for the first MWG meeting and to begin examining carbon and electricity markets, the UTC and Commerce solicit proposals for educational topics and presenters. Proposals should explain the specific connection to the issues that must be resolved under RCW 19.405.130. The UTC and Commerce will work with stakeholders to develop a set of presenters for the next MWG meeting.

NOMINATIONS AND WRITTEN COMMENTS

The Commission gives notice of your opportunity to submit, no later than 5 p.m., Thursday, November 7, 2019, nominations for membership in the MWG and written comments on educational topics and speakers for the MWG's first meeting.

Pursuant to WAC 480-07-250(3), nominations and written comments must be submitted in electronic form, specifically in searchable .pdf format (Adobe Acrobat or comparable software). As provided in WAC 480-07-140(5), those comments must be submitted via the Commission's web portal at www.utc.wa.gov/e-filing. If you are unable to submit documents via the portal, you may submit your comments by email to the Commission's Records Center at records@utc.wa.gov or by mailing or delivering an electronic copy to the Commission's Records Center on a flash drive, DVD, or compact disc that includes the filed document(s). Comment submissions should include:

- The docket number of this proceeding (Docket UE-190760).
- The commenting party's name.
- The title and date of the comment or comments.

The Commission will post on its web site all comments that are provided in electronic format. The web site is located at <u>Docket 190760</u>.
