**Network Notification** 

CLECs, Resellers, Wireless, IXC, ILECs New E911 Tandems - Washington

This is the second notice (third for Spokane) sent regarding the addition of alternate E911 tandems being installed in the State of Washington. The State of Washington E911 Office in conjunction with the impacted Public Safety Answering Points (PSAPs) has requested additional diversification of the E911 network to conform with current E911 system design standards. As a result, Qwest is diversifying to three E911 dual tandems for the state. This new configuration will require that the various Trunks be diversified between the appropriate tandems. Completion of the project will be by June 30, 2005.

The State of Washington currently has a dual tandem configuration for King County (Seattle area) and 6 other stand alone Selective Routers (SRs). Qwest will consolidate the Tacoma and Bremerton SRs into the existing dual tandem configuration in Seattle. The Vancouver SR will also be consolidated into the existing Portland dual tandem router pair. Lastly, the existing Spokane, Yakima, and Pasco SRs will be consolidated into a dual tandem configuration. The Washington E911 customers working via the Spokane, Yakima, and Pasco SRs will be reconfigured into a new Spokane SR and existing Yakima SR dual tandem arrangement.

The second notice for Spokane was sent February 9, 2005. Note that this notification not only decommissions the SPKNWA0154T SR but also the PASCWA011GT SR. More details can be found in this second Spokane notice, Notification Number: NETW.02.09.05A.001311.E911 Tand Decommission.

The reason for this notice is to inform you that the State of Washington E911 Office has requested that all Emergency Service (ES) trunks be diversified between the appropriate two tandem SRs. We are asking for your cooperation in the diversification of your ES trunks between end offices and the respective E911 Tandems. In some cases, carriers have needed to install trunks to multiple tandem routers serving their service territory. You are encouraged to examine your trunking configurations to eliminate trunking that may not be needed due to the larger service territory of the router pairs. In order to complete the diversification by June 30, 2005, you may start

placing your orders beginning May 2, 2005 but no later than June 1, 2005.

In addition, if your ES circuits have not been upgraded to SS7 signaling, the State of Washington E911 Office is requesting that this be done at the same time.

- 1. Completion of the E911 worksheet
- 2. Setting a Due date (minimum interval of 12 days after receipt of a complete and accurate E911 worksheet).
- 3. Working with PSAP to ensure backup coverage during the conversion
- 4. Conversion of trunks during a Maintenance Window
