Re: UE-210878 – Puget Sound Energy’s 2022 Distributed Energy Resources Request for Proposals – Demand Response Agreement with Enel X North America, Inc.

Dear Director Hunter:

Pursuant to Washington Administrative Code (“WAC”) 480-107-035(7), Puget Sound Energy (“PSE”) hereby files with the Washington Utilities and Transportation Commission (“Commission”) the attached agreement executed with Enel X North America, Inc.¹ The agreement, which was executed on September 26, 2023, is the third and final agreement executed as a result of PSE’s 2022 Distributed Energy Resources Request for Proposals (“2022 DER RFP”).²

Under the provisions of WAC 480-07-160, PSE requests that this filing be accorded confidential treatment. Vendor specific information and other commercially sensitive financial data are included in the executed agreement and supporting materials. As required by WAC 480-07-160(3)(b)(i), PSE has properly identified all pages containing proprietary information.
