SCHEDULE 90-T BASIC FIRM TRANSPORTATION SERVICE

AVAILABLE:

To Non-Residential Customers, up to a specified MDDV, in all territory served by the Company under the Tariff of which this schedule is a part. On-site Alternate Fuel Capability is required, subject to **RULE 19**, except where Customer has secured firm Pipeline delivery to Company's Receipt Point. The Company may require: (a) that Customer provide active and continuous telephone and electric service to the meter(s); and/or (b) that Company-owned telemetry equipment be installed by Company at Customer's Premise, subject to charges set forth in SCHEDULE C. No seasonal or temporary disconnection of service is permitted. Customer must comply with the provisions of **SCHEDULE T**.

SERVICE DESCRIPTION:

Service under this schedule is ~~subject to the provisions of SCHEDULE T~~ for the Transportation of Customer-Owned Gas on the Company's distribution system under a written Service Agreement, for a term of not less than one year. Service under this schedule is firm capacity on the Company's system. Customer agrees to transport the entire firm fuel requirements of facilities served under this schedule.
