The Alliance of Western Energy Consumers (“AWEC”) submits this letter to notify the Commission that it will not be filing Rebuttal Testimony to Public Counsel’s Response Testimony to the July 8, 2022 Full Multiparty Settlement Stipulation (“Stipulation”). However, AWEC continues to support the Stipulation, finding that it results in just and reasonable rates as demonstrated by the Joint Testimony in support of the Stipulation.
