1 Pursuant to WAC 480-07-385, all parties jointly move for a continuance of the evidentiary hearing date in this matter and associated filing dates. A continuance is in the public interest because it will permit the parties to pursue settlement options.

2 Representatives of all parties met in person on November 29, 2010 to discuss the potential for settlement. The parties determined that they need additional time to exchange and evaluate potential settlement options. The parties' objective is to determine by the end of 2010 whether agreement among the City of Fife, Union Pacific Railroad, and UTC Staff can be reached and an adversarial hearing avoided. The parties believe that postponing all remaining deadlines in this matter by approximately 30 days will assist them in making that determination.


