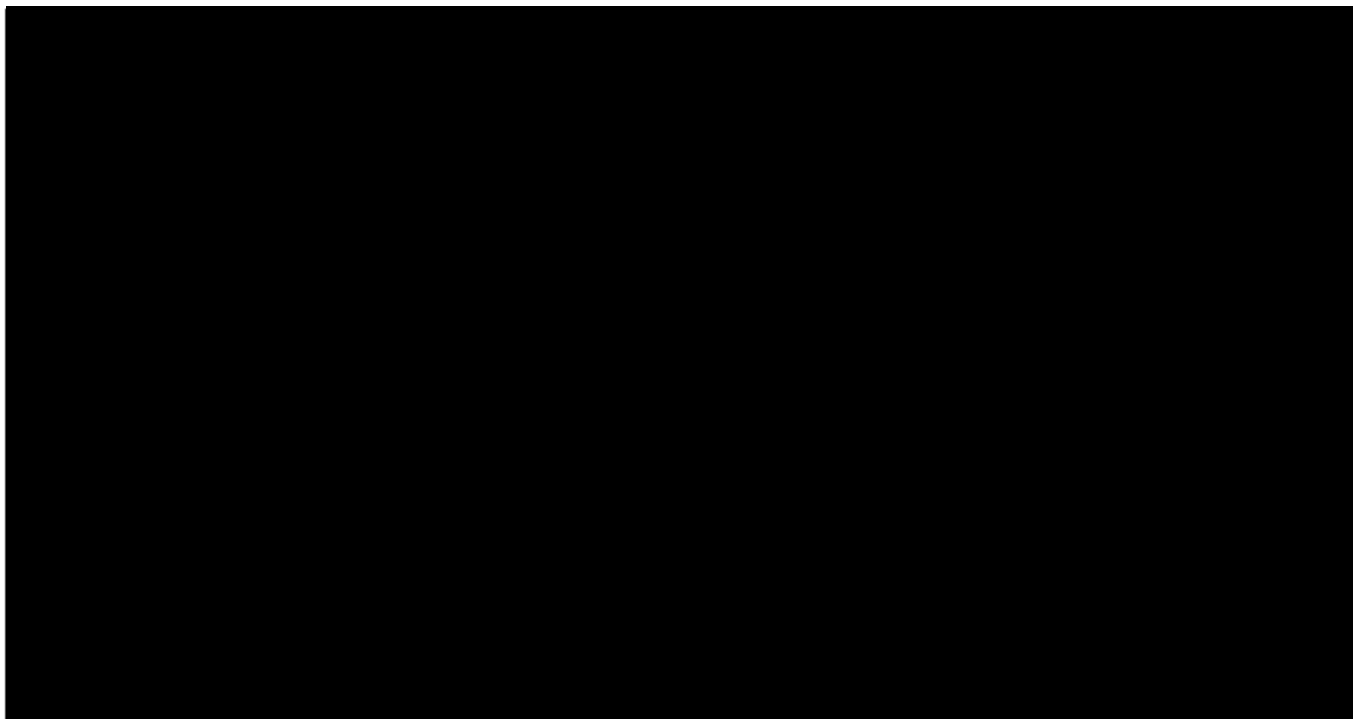

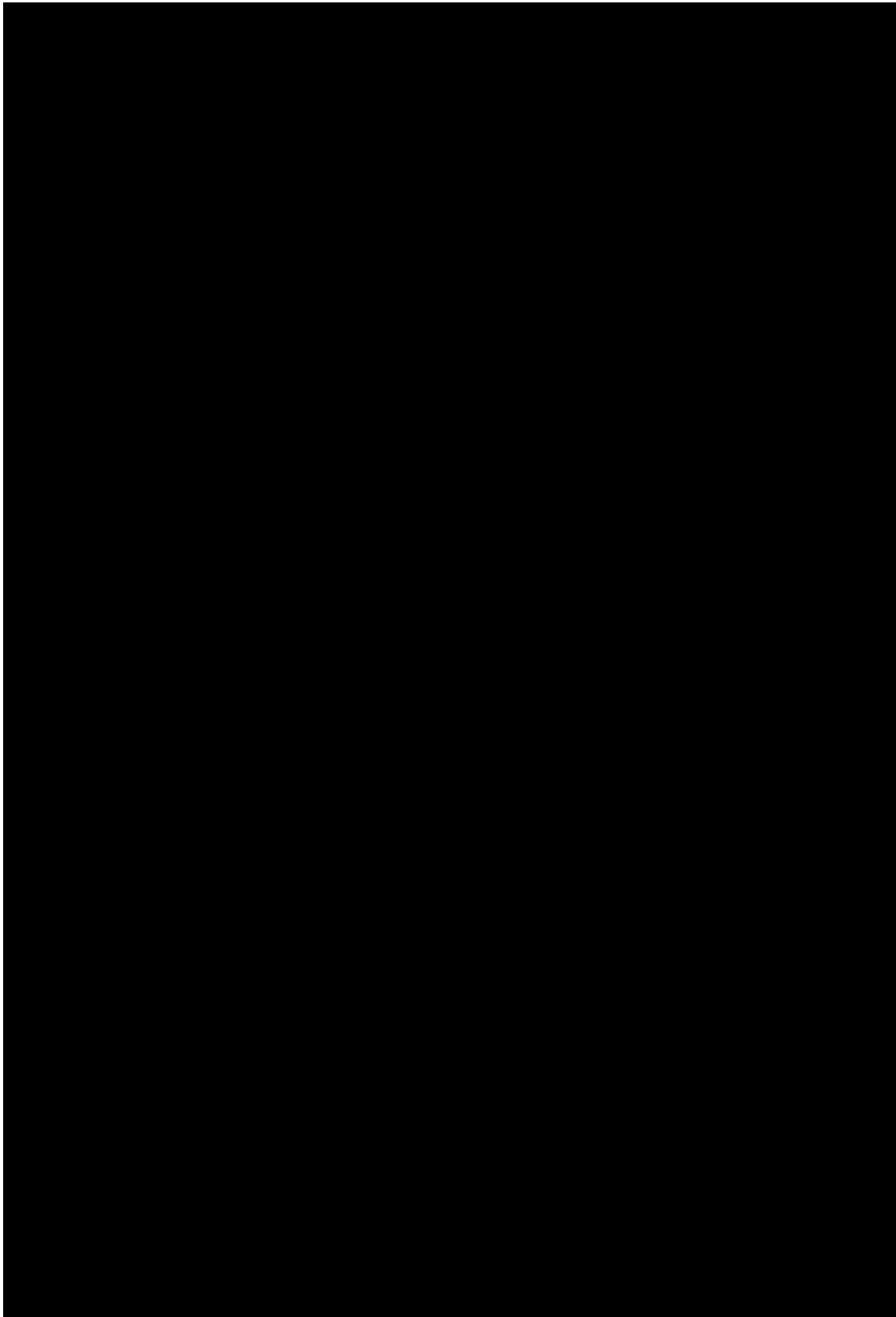

**Fixed Broadband Subscriptions by State, Technology and End-user Type**

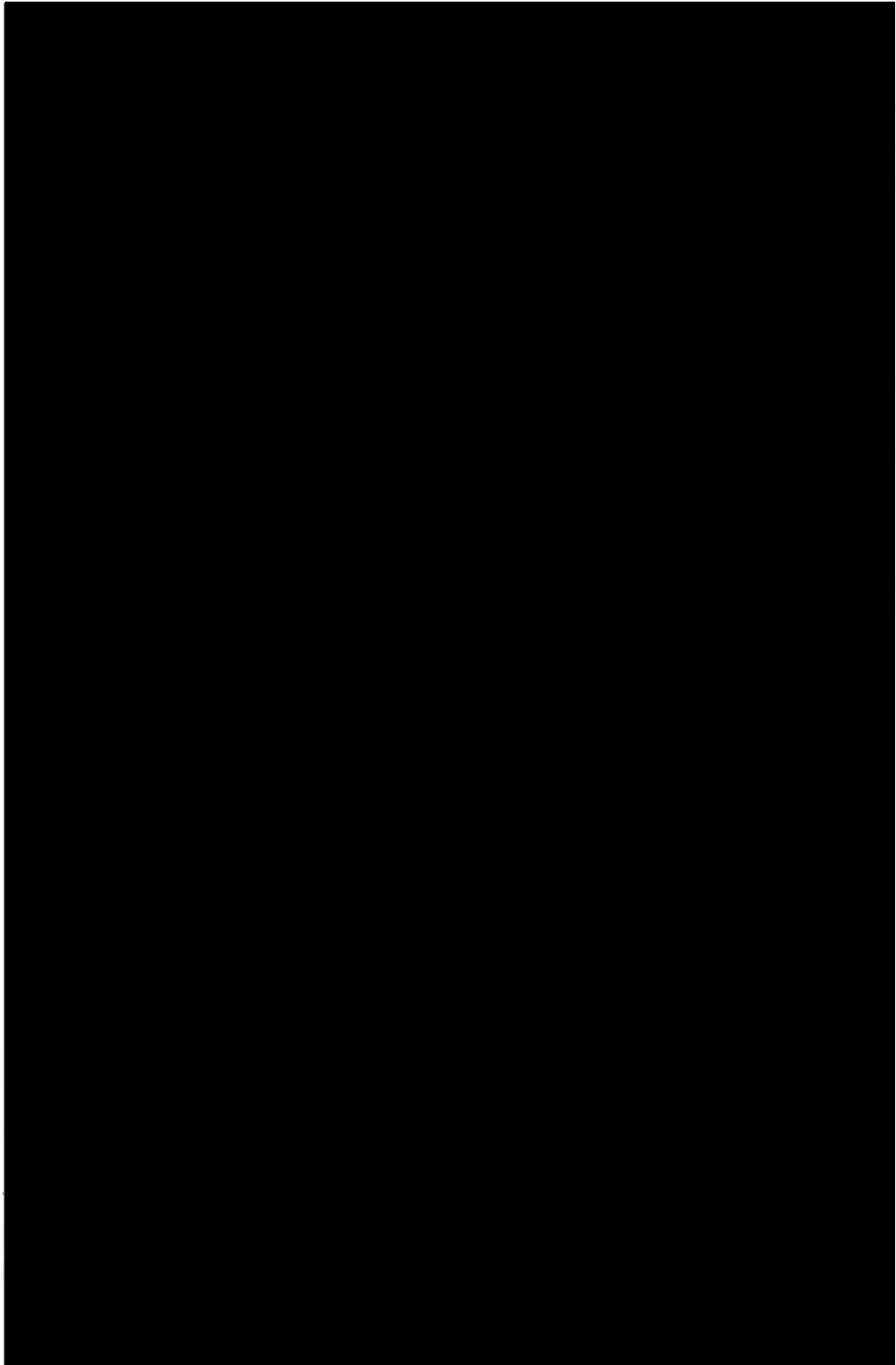
