On March 20, 2014, the Washington Utilities and Transportation Commission (Commission) entered Order 03 - Final Order Granting In Part and Denying In Part Staff's Motion To Strike and Approving Tariff Language to Address Disruption of Service due to Work Stoppage, in these dockets. Order 03 authorized and required Waste Management of Washington Inc., d/b/a Waste Management - Northwest, et al. (Waste Management) and Rabanco LTD, d/b/a Container Hauling, et al. (Rabanco) to file tariff sheets consistent with the terms outlined in Order 03.

On April 3, 2014, Waste Management filed tariff sheets as specified in the order. On April 3, 2014, Rabanco filed incomplete tariff sheets that were corrected in subsequent filings. A list of the tariff sheets is attached to this letter. Commission Staff has examined all of these filings and concluded that the tariff sheets, as listed in the attachment, appear to comply with the terms of the Order.

On April 4, 2014, the Commission issued an Erratum to Order 03 that authorized the Commission Executive Director and Secretary to approve the filings by letter if they complied with the terms of the Order.

Therefore, pursuant to the terms of the Commission's Order 03 in this proceeding, the tariff sheets indicated on the attachment to this letter will become effective as filed with an effective date of April 11, 2014.
