RE: In the Matter of the Joint Application of Northwest Fiber Holdco, LLC, and BCE Holding Corporation for an Order Approving the Transfer of Control of Ziply Fiber Northwest, LLC to BCE Holding Corporation, Docket UT-240951

TO ALL PARTIES:

On December 12, 2024, Northwest Fiber Holdco, LLC (Northwest) and BCE Holding Corporation (BCE) filed a joint application requesting that the Washington Utilities and Transportation Commission (Commission) enter an order approving the transfer of control of Ziply Fiber Northwest, LLC d/b/a Ziply Fiber (Ziply) to BCE.

On May 13, 2025, the Commission issued Order 02, Prehearing Conference Order; Notice of Hearing (Order 02), which established a procedural schedule. The procedural schedule allowed for a public comment hearing to be scheduled at a later date.

On June 11, 2025, the parties attended a settlement conference and informed the Commission that they had reached a settlement in principle and requested an expedited hearing on the

settlement.¹ The parties further agreed to the hearing being presided over by Administrative Law Judges, sitting without the Commissioners, who will issue an initial order after the hearing on the settlement.²

Based on the parties' agreement, the Commission finds good cause to amend the procedural schedule to expedite a hearing on the settlement in principle reached by the parties.³ Settlement, even if yet unapproved, potentially avoids the administrative expense of an evidentiary hearing. This would further both the public interest and the Commission's administrative needs. Built consensus is always welcome.

The Commission finds good cause to amend the procedural schedule as to allow an opportunity for the parties to finalize their settlement agreement. By July 7, 2025, the parties must file either a settlement agreement with supporting documentation, or proposed amendments to the procedural schedule.

Further, the Commission now establishes the time for a virtual public comment hearing to provide members of the public with an opportunity to present oral comments to the Commission on the issues raised in this matter. THE COMMISSION GIVES NOTICE That the parties must file a settlement agreement, with supporting documentation and testimony in support of the settlement, or proposed amendments to the procedural schedule no later than 5 p.m. on Friday, July 7, 2025.

THE COMMISSION GIVES FURTHER NOTICE That the procedural schedule issued in Order 02 is suspended, and the Commission will hear this matter virtually on July 14, 2025, at 9:00 a.m.; the presiding officers of this hearing will be the Administrative Law Judges assigned to this docket, who will subsequently enter an initial order.

THE COMMISSION GIVES FURTHER NOTICE That the Commission will hold virtual public comment hearings in this matter at 6 p.m. on Wednesday, July 16, 2025.
